To achieve strong, annual total returns over the medium to long term through defensive investment in the large cap Australian equities asset class.

The Defensive Share Portfolio

The past 12 months has seen the ASX 200 index surpass the 6,000 points barrier, a sharp correction in late February, and now it has returned to a fast ascent. This volatility provides a timely reminder of the unpredictable nature of stock markets and the speed at which corrections can take place. Investors tend to forget this when the market is dancing in record territory, but for how long can this latest Bull Run last? Hence, investment philosophies must be built on rigid academic and quantitative foundations; and those implementing them must display discipline regardless of market direction or sentiment. The Investstone Wealth Management Defensive Share Portfolio embodies this philosophy, and was established to provide investors with absolute returns.

The Defensive Share Portfolio is designed to meet the needs of conservative investors, who realise the importance of being exposed to the stock market but are not comfortable with extreme volatility. The defensive share portfolio achieves this by investing only in financially robust companies that offer higher than average yields, and are trading at a fair price. This follows the belief that companies displaying these characteristics are less likely to suffer during a downturn, therefore preserving investor's capital.

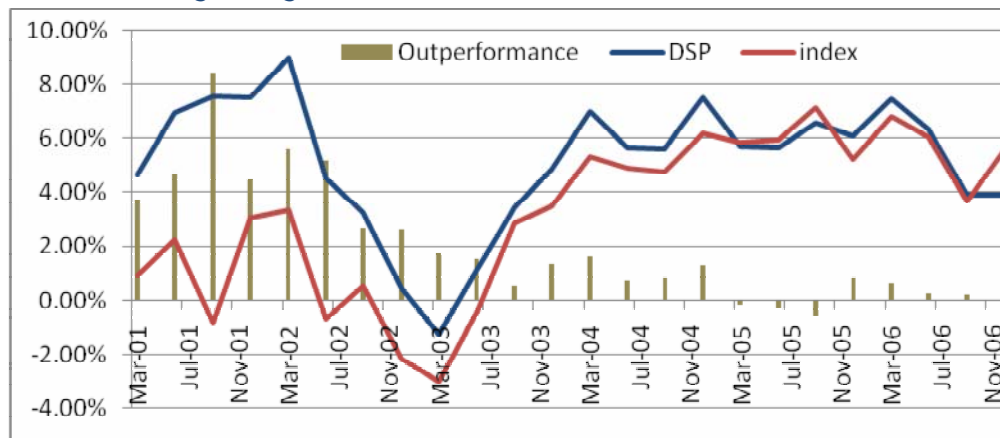
Performance Summary

The record over the past seven years strengthens the logic underpinning this approach. The table and graph below illustrate the performance against the ASX 200 and All Ordinaries Index. The Defensive Share Portfolio has continued to achieve significant returns to investors, particularly during market downturns, yet has also achieved solid growth during subsequent Bull Runs. Since inception the Defensive Share Portfolio has delivered a return of 20.54% per annum, compared with the market return of 13.92% per annum.

This capital gain is passed on to all investors in the fund. In other words, you may have to pay more tax or tax at a time that may not suit you because other investors have chosen to withdraw their money from the fund.

- investing in managed funds can lead to the problem of embedded capital gains, whereby you inherit the tax position of the fund at the time of investment. This can lead to situations where you inherit a tax liability for actions the manager took *before* you invested in the fund.

Investstone Wealth Management has sought to revolutionise the managed investment service by insisting on a performance only fee structure. This, when coupled with a low 0.6% administration fee, makes investing with Investstone's SMA a low cost option for DIY investors.
